Eligibility:

- a) Any individual who is a member of the immediate family of another director is not eligible to be a director;
- b) Any delegate of a member belonging to either the business or the partner category is not eligible to be a director;
- c) Any individual who is a shareholder, owner or officer of a client business of the SADC is not eligible to be a director;
- d) Any officer, shareholder, member of a society or employee of an association, corporation or other organization or federation whose objectives are, in part or in whole, similar to those of the SADC, in the opinion of the Board of Directors, is not eligible to be an officer or to become an officer on the Board of Directors.
- e) Any person under guardianship or curatorship, or declared incapable by the court of another province, territory, state or country or a political subdivision thereof, is not eligible to be a director;
- f) Undischarged bankrupts are not eligible to be directors;
- g) Employees of the SADC are not eligible to be directors.
